### 有關: 愉翠苑實行垃圾收費問卷調查結果

有關愉翠苑垃圾收費事宜, 本會曾向 4,176 戶所有業戶作出問卷調查。於 2024 年 02 月 29 日由本會委員及另外兩名業戶見證下, 收回及開啟放置於各座的問卷收集箱。是次調查共收回 1,054 份問卷, 佔全苑 4,176 戶的 25.24%, 有關結果如下:

#### (甲) 調查結果摘要

#### (乙) 結果分析摘要

綜合上述調查結果, 55.88% 回應業戶同意選擇方案三, 由屋苑聘請承辦商將垃圾運至堆填區或廢物轉運站; 30.74% 回應業戶選擇方案一, 業戶按家庭所需自行付費購買指定垃圾袋; 7.88% 回應業戶選擇方案二, 屋苑提供全苑所有單位 20 公升容量指定垃圾袋;

### Re: Survey Results on the Implementation of Municipal Solid Waste Charging at Yu Chui Court

Regarding the Municipal Solid Waste Charging of Yu Chui Court, the Owners' Committee (OC) conducted a questionnaire survey to collect all residents' views from all 4,176 units. Under the witness of the OC members and two residents, the questionnaire collection boxes placed in each block were collected and opened on 29 February 2024. A total 1,054 questionnaires were collected in this survey, accounting for 25.24% of the 4,176 units in Yu Chui Court. The survey results are as follows:

#### (A) Summary of Survey Results

#### (B) Summary of Analysis

Based on the above results, 55.88% of the responding residents agreed the MSW charging by option 3, hiring of contractor by estate to deliver waste to landfills or refuse transfer stations. 30.74% of the responding residents agreed the MSW charging by option 1, residents to pay for the purchase of designated bags according to the household needs. 7.88% of the responding residents agreed the MSW charging by option 2, all flat units in the estate will be provided with 20-liter designated bags.

Regarding the arrangement of waste charging at Yu Chui Court, we will discuss the implementation and related arrangements with the customer service office based on the opinions of residents.
