有關愉翠苑新管理合約的安排事宜,本會曾向 4,176 戶所有業戶作出問卷調查。於 2023 年 3 月 6 日由本會委員與本苑業戶見證下,收回及開啟放置於各座的問卷收集箱。是次調查共收回 2,074 份問卷,佔全苑 4,176 戶的 49.66%,有關結果如下:

(乙) 結果分析摘要

綜合上述調查結果,95.71%回應業戶贊成於 2023 年 6 月 30 日愉翠苑管理合約屆滿後,續聘現時管理公司「康業」;2.99%回應業戶則贊成重新招標。

上述問卷調查結果只供參考,因按《建築物管理條例》,無論續聘「康業」或重新招標,均需交由業主大會表決通過,因此本會將籌備召開業主大會,有關業主大會議程及大會日期等安排細節,將於日後再作公佈,敬請留意。

Re: Survey Results for the Year 2023 Procurement of Yu Chui Court Management Service Contract

Regarding the arrangement for the new management service contract of Yu Chui Court, the Owners' Committee (OC) conducted a questionnaire survey to collect all residents' views from all 4,176 units. Under the witness of the OC members and owners of the estate, the questionnaire collection boxes placed in each block were collected and opened on 6 March 2023. A total of 2,074 questionnaires were collected in this survey, accounting for 49.66% of the 4,176 units in Yu Chui Court. The survey results are as follows:

(A) Summary of Survey Results

Contract arrangement after expiration of the current Yu Chui Court Management Service Contract on 30 June 2023

(B) Summary of Analysis

Based on the above results, 95.71% of the responding residents agree to re-appoint the current management service agent "Hong Yip Service Co. Ltd." after expiration of the current Yu Chui Court management service contract on 30 June 2023. 2.99% of the responding residents agree to re-tender the management service contract.
